To paraphrase and old saying, "When God closes a door, he opens a browser window."

Federated Church is now an online worshiping community! With help from those more tech savvy than me (a HUGE thank you to Bill and Brian!), we offered worship services via Facebook and YouTube once our doors closed due to the pandemic. We now also offer livestreaming for worship services on Sunday mornings, so we can worship together, at the same time.

Going online proved to be a steep learning curve! Everything from the liturgy to the lighting to the licensing to the lyrics to the look of the pastor's suit jacket was re-thought and re-tooled for the camera. What's more, all this happened during Holy Week, the week between Palm Sunday and Easter when we offer four, distinctly different worship experiences.

Know what I learned? Preaching to an empty room is harder than preaching to a crowded sanctuary, and there is no one there to laugh at my jokes!

The truth is, however, that closing our doors forced us to try a new medium for worship, and we reaped some unexpected blessings.

More people are worshiping with us now. Online worship reaches into the homes of people who cannot physically join us in the sanctuary, and people can worship when it is convenient for them. Did you know that we had 414 "hits" on our Easter Sunday service? That is more than our sanctuary seats! And many of those hits represented couples or families, so our "online congregation" was HUGE on Easter. Praise God!

Our worship is reaching coast to coast, and beyond. We regularly receive emails from people who viewed our worship service from their homes in Maine, California, Texas, all around Minnesota, and even from a friend in Guatemala! Federated Church is becoming part of the global congregation.

We shared some great music. Brian Jensen really stepped up, purchasing some new sound equipment that allowed us to record individual singers and parts while maintaining safe, spatial distance. In fact, Brian himself is featured on much of our musical offerings. He and I "played" a lot during the at-home time: he at the mic and me at the piano, and we now have a nice library of hymns with Brian's voice. Such a blessing.

We stayed connected, even while we were apart. The marvels of modern technology allowed us to stay connected, to offer our prayer and praise, during a difficult time. I am grateful for that, and for the opportunity to expand our ministry.

Jesus said that wherever two or three are gathered, he is there among them. I believe that Jesus was with us in our virtual worship, and that he smiled on our efforts to be the church at worship.

We are now worshiping in the sanctuary again, and it is good to be back and to see people again. For those who are not yet ready to be in public worship, we support your decision. Please worship with us online – your virtual presence is welcomed.

I imagine this is the first of many things that will be different as we move forward, but I'm not afraid of what will come. We got this!

Some Thoughts about Online Worship and Copyright Concerns

Offering our worship services online (YouTube, Facebook, live streaming, etc.) carries with it some new responsibilities, most notably copyright concerns. Adhering to copyright laws is a matter of social justice: it ensures that the artist or author gets credit and/or compensation for their work.

"Copyright" is the legal protection of a creative work. Using a work without permission that is under copyright is against the law and penalties can be financially severe. There is no exemption from copyright law for churches. Creative works are protected for 95 years (if published before 1978), or the life of the creator of the work plus 70 years if published after January 1, 1978. Remember, the work is the property of the person who created it. To use it without permission is stealing.

Copyright law applies as soon as something is documented (written or recorded) even if it is not registered. This includes all "intellectual property" such as music, sermons, and prayers. Federated Church services are accountable under copyright law and may not be "re-broadcast." Anyone videoing and either uploading to social media or live streaming is open to copyright claims by the music copyright holder.

• An example: taking a personal video on your phone during the service and posting that video on social media is considered re-broadcasting. This is not allowed under copyright law. It is okay to share the link to a Federated Church video in an email or a text. This is not considered re-broadcasting as it directs the viewer to the original post.

Music always requires copyright permission to use, especially for live streaming services. In many cases, two copyrights/permissions are

required: one to use the music and one to broadcast the music online.

- An example: many older hymns are in the "public domain," which means we are free to use them in worship, but that does not mean we have permission to stream them. A second license is required.
- Another example: when we use a hymn out of our hymnal, and the congregation sings it, we have permission to use it for worship because we purchased enough hymnals for each worshiper. This does not apply, however, to the online worshipers who do not have a hymnal at home. Thus, we need a second license to stream the hymn.

Identifying members or children by name poses a security issue. We will endeavor NOT to name anyone in our recorded services. This pertains specifically to prayer requests.

• An example: if someone asks us to pray for their sister Mary Smith is in the hospital with a broken hip, we have just notified everyone (worldwide!) To whom she is related, that she is incapacitated, that she will be laid up for a long time, and that her home may be empty! When prayers are requested, please limit the request to first name and a general concern: "please pray for Mary who needs healing."

We are being very diligent about working within the copyright guidelines. Both the PCUSA and the UCC have excellent resources online to assist churches with this. Please know that if we ask you to refrain from posting something, or cannot sing your favorite praise song when you request it, or we cease asking for prayer requests during the service it is because there are copyright concerns. Please extend us some grace as we navigate this complicated issue.
