Camp In A Bag?! - Karen Anderson Dent

Greetings to our Federated family! What a spring this has been! I have so missed seeing all of you for Kidz Club, youth groups, Sunday school, and worship! As we look to the summer I have been weighing the pros and cons of various programming opportunities we traditionally provide at Federated Church.

Vacation Bible School is, by far, the most exciting and energetic week of our year, and so it is with great sadness I share with you that Clearwater Forest Camp cancelled ALL summer programming, including Camp-in-a-Van, for Summer 2020. When taking into consideration the fact that our VBS relies HEAVILY on adult and older youth volunteers, I have concerns that we would not be able to properly "staff" the program this year. With all of the restrictions and challenges before us this summer, I am developing a new approach to Vacation Bible School for Summer 2020: Camp-in-a-Bag! Camp-in-a-Bag is literally a bag with contents guiding families through Bible stories, crafts, music, and outdoor activities of VBS while at home on a schedule that works for them. I am creating a fiveday program which will be available for pick-up at church, hopefully by the last week of June (when we traditionally hold VBS), but contingent upon the arrival of any materials needed for crafts. It isn't the "ideal" Vacation Bible School we love, but it will give families a chance to do something faith-based during summer.

Our theme is "Hope Rises" and will focus on God's care for us through challenges. We will study people from the Bible who grew in faith and love while encountering crisis. I am excited to provide this opportunity for families to do together! You will receive notification through postcard, email, and text notification when the bags are available, and we will have set times when individuals can come to the church to pick up their bags. If you would like a bag but are unable to come to the church to receive one at the set time, please contact the church office and let us know.

Pastor's Pen

Dear Federated Family:

As Bob Dylan famously sang, "The times they are a changin'!" We live in extraordinary times. A world-wide pandemic. Stay-at-home orders. School and work at kitchen tables. Businesses and churches closed. Necessities in short supply. We are adapting to a new way of living.

At Federated Church, we are adapting to new ways of worship and working, too. Fortunately, we live in an age when there is technology available to keep us connected. We are using electronic means to offer our worship to God and conduct the business of the congregation.

So, to business! The Presbytery of Minnesota Valleys recently advised us that to legally conduct meetings electronically (internet, telephone, video conferencing), we need to include a provision authorizing those means in our corporate bylaws.

The Deacons & Elders met (via ZOOM) on May 21, 2020 to discuss and recommend to the congregation an addition to our bylaws authorizing electronic meetings. The proposed bylaw addition is printed in this newsletter (XVI. Electronic Meetings). Changes to the Federated Church bylaws require approval by the congregation. Since we are unable to meet due to spatial distancing, the Deacons & Elders are providing ballots for you to vote and return by mail. Please read the proposed bylaw addition. If you have questions, please contact Pastor Doug Dent (218-205-5795) or Clerk Jean Bowman (218-205-1251).

When you are ready to vote, print and sign your name, check the appropriate box on the enclosed card, and return it to the church office. Please have all voting members in your household (including confirmed students) use the same voting card.

Your vote matters: we need a minimum of 55 affirmative votes (10% of our membership) for this bylaw to pass. Results of the vote will be published in a future newsletter and reported at the Annual Meeting of the Congregation in January 2021.

Proposed Addition to Bylaws

MOTION: to recommend to the Federated Church congregation the following addition to the bylaws:

XVI. Electronic Meetings

The Federated Church and any of its committees, task forces, employees, or other entities are authorized to meet by electronic means (i.e., internet, telephone, or video conferencing) at such time and means as determined by the moderator or chairperson of the particular entity, provided the following conditions are met:

The technology employed provides the opportunity for simultaneous communication (listening and speaking) among all participating members.
The meeting notice includes adequate description for how to participate in the meeting (i.e., voting procedure), including telephone numbers

and codes to be used, links to meeting rooms, and

• Arrangements satisfactory to the member can be made for the participation of any member who lacks the necessary equipment without incurring personal expense.

All members may participate fully and can be recognized when they wish to speak/comment.
A quorum must be present throughout the meeting. Any member has the right to demand a roll call at any time if they doubt the presence of a quorum, unless the technology employed can determine the number present in another way.
Minutes shall be taken, and all votes recorded. Voting procedures are deployed with adequate instructions for use of the technology and in accordance with the Book of Order.
