- I. **Opening Prayer** (The meeting was called to order at 10:30 a.m.)
  
- II. **The Call to Order**
  1. Quorum was declared (10% of Active Membership or 35 members). There were 56 members in the sanctuary.
  2. **Motion #1:** To approve the agenda. Motion carried.
  3. We reviewed the minutes from the 2022 Annual Meeting (1/23/22). These were approved by D&E on February 17, 2022.
  
- III. **Pastor's Report** A written report was included in the annual report. In three weeks it will have been 20 years since Doug answered the call to serve as our pastor. He thanked the congregation for the many blessings they share. Last year we celebrated our 150th anniversary. "Let us not grow weary of doing good," said Doug. VI. **Ordination and Installation of Officers**

Ingrid Morgan and James Michael were ordained as officers. Jeremy Jensen and Sonja Johnson were previously ordained. All four were installed as officers on the D&E board.

VII. **Committee Reports**

Committee reports are included in the annual report. There were no questions.

VIII. **Financial Reports**

The budget committee, board of managers and D&E prepared and approved the balanced budget being presented this morning. Doug presented the budget with the following highlights: **Revenue Notes:** An increase in pledges (over 2022) with 57 households that raised their pledge amount, 42 held at the same level and three households pledged for the first time. We have some savings compared to 2022 in staff

(AV technician and director of pastoral care) as well as reduced costs for snow removal and copier rental, among other things. **Expense Notes:** A 3.5 percent salary increase is recommended for staff who met/exceeded performance. Additional expenses include a new computer for the office, pulpit supply (this is a sabbatical year, so there are more dates to cover), increased utilities, a request from the mission team and the new position of choir director.

The fall of Jerusalem in 586 B.C. was a tragic turning point in Israel's history. It was also the climax of Jeremiah's prophetic ministry. God's judgment had come to pass. Jeremiah obeyed God and spoke the truth, but the fulfillment of his messages grieved him deeply. In response, he wrote the book of Lamentations. These poems connect the justice, sovereignty, and love of God and ultimately affirm that God's mercies are "new every morning."

The Babylonians heard of Jeremiah and his prophecies, which turned out to be a mixed blessing for him. He wasn't forced into exile but was set free to go wherever he liked. Jeremiah's ministry continued. The word of the Lord continued to come to him. The Babylonians thought they were in control, but it was the Lord. The pagan superpower was following God's plan exactly. This is why Jeremiah could continue to trust in the Lord even while lamenting the loss of all he'd ever known.

The COVID pandemic turned out to be a mixed blessing for the church. While we shut down for a time and did not meet in person, our ministry to the community continued. We found new ways to be faithful witnesses to God's goodness and sovereignty over our lives. The pandemic tried to stop us, but God proved – yet again – that God is greater than the powers of this world.

One of those mixed blessings is online worship. Had it not been for the pandemic, we might not have tried this new form of ministry. But we did, and it is proving to be a blessing to many. The initial headaches of updating our equipment, finding a streaming service, and navigating copyright law have given way to an evangelistic tool that reaches people around our community, around our country (Arizona, California, Florida, Maine, and Pennsylvania), and around God's world (Canada and Guatemala!).

In 2023, our in-person attendance averaged 90 people, and our online attendance averaged 61 households. Each time a household logs on to watch our service, it counts as one "view" on the streaming service ticker. But what if there are two people in the household, or a family of five? We still only able to record one "view" per household. I am confident that our online presence is reaching at least as many people as our in-person worship services. And that means *more* people are worshipping with us now than worshipped with us prior to 2020. What a blessing!

Other benefits of online worship include being connected with your church family from wherever you are, turning the volume up or down to suit your comfort level, watching worship at your convenience, watching worship again if you really enjoyed it, and posting a worship service for friends to enjoy on social media.

But remember, online worship is a mixed blessing: it can become all too easy for us to sit at home and worship in our pajamas. The Body of Christ, the church, needs you to show up from time to time. We are better together, and our ministry is diminished without you.

My challenge to you for 2024: keep worshipping with us but be intentional about worshipping in person as often as you can.

## **Board of Managers**

John MacFarlane & Skip Zielin

The Board of Managers provides oversight of all property of the church (maintenance and repairs), the payment of bills, and oversight of Federated's finances.

This year continued to be challenging as our Grand Old Building continues to need care. Excessive utility use caused us to exceed our 2023 budget.

### **MAIN PROJECTS COMPLETED IN 2023**

**Financial Review:** The Board of Managers contracted with Smith and Sem CPA to handle payroll functions. After our last bookkeeper resigned, we found an overwhelming number of issues that had to be corrected. This resulted in additional hours for our new bookkeeper and expense for the church. Jerry Nuss and Mariah Davenport from this committee have given so much effort in helping with this.

**Heating system:** The heating system continues to make a lot of money for the Boiler Repair Company.

**Balcony Repair:** A part of the south ceiling and wall were removed to repair a condensation problem.

**The Parking Lot:** A large crack between the mall building wall and the parking lot was filled again.

**Fellowship Hall.** This area again suffered water leakage during heavy rain last summer. A basement type water drain system and sump pump was installed that will correct the problem.

### **SPECIAL PROJECTS COMPLETED IN 2023**

**Pew Cushions:** Thanks to several generous donations we were able to replace all the pew cushions in the sanctuary. We are grateful to our donors!

**Nursery:** William Nuss renovated the church nursery as his Eagle Scout Project using volunteer labor and funds provided by the BOM and memorials IMO Carri Thompson. Thank you, William!

### **ANTICIPATED PROJECTS FOR 2024**

**Stucco:** On the south side of the building was to have been repaired last summer. This project didn't get done but will be completed early summer 2024.

**Parking Lot:** Seal coat and restripe the parking lot.

**Landscaping:** the south side of the church with mulch and edging. Labor will be provided by the Men's Club.

## **Christian Education**

The Rev. Karen Anderson

The Christian Education ministries at Federated Church continued to build after the challenges of 2020-2021. With great leadership, we are seeing more families engaging, young people bringing friends, and a new energy and purpose to our varied ministries.

### **Kidz Club**

As we kicked off 2023, our Kidz Club group continued our 2022-2023 theme of “God’s Big Story”, which followed the movement of God throughout Bible history. Starting with the story of creation, we learned how God worked through people to tell His story of love and grace. We heard all the main Old Testament stories including Abraham, Jacob, Moses, Joshua, the Judges, the Kings of Israel, the Prophets, the life of Jesus, Paul, and the Apostles, and finally ended with US! We learned that we are an important part of God’s continuing story! This fall, we began the “Year of Jesus” which closely follows Jesus’s life and ministry. We began by learning His parables, and then as the season approached, we studied the story of His birth. We will continue this theme into 2024 by learning about Jesus’s life and ministry, the miracles He performed, and His death and resurrection. We have snack time, story and music time, crafts, and gym time. Our wonderful volunteer leadership includes Caroline Anderson, Siri Anthonisen-Brown, Melissa Davenport, Madalyn Dent, Jonathan Dent, Lu Echelberger, Kristian Fransen, Claire Gutzmer, Beth Schlepp, and Char Zielin. In the kitchen we have been blessed with the leadership of Roxane Nereson, Jane Nelson, Gail Green, and this past spring—Mary Ann Nead. This ministry requires a huge group effort, and we have developed a wonderful team! Please let me know if you would like to serve with us—we are always willing to welcome more help!

### **Sunday School**

Sunday school continues to slowly gain momentum again after the pandemic pause. We are adding numbers as we grow—both with families who can reconnect as well as new families to our ministry. We have a monthly Pre-K and Parent class run by Cindy Spidahl and Jill Iverson. This younger group gathers for fun learning and purposeful fellowship. During the spring months, our K-6 students, led by Jona Brown/Madalyn Dent (K-1), Kristian Fransen/Sam Ebert (2-4), and Karen Bush/Karen Anderson-Dent (5-6) studied the Ten Commandments, going through each in an age-appropriate fashion. This fall we began learning about the Fruit of the Spirit, which we will continue after our annual pageant practice times. In the spring, our middle school/senior high school class, led by Hollis Davenport, addressed which sayings that we hear are in the Bible, and this fall they have looked at how science factors into the Bible and our faith. I can honestly say that we have an incredible dedicated teachers who really love to share their faith and knowledge with our young people. We are very blessed to have the teaching team that we have!

### **Confirmation**

Our confirmation classes continue to meet each Wednesday 7-8<sup>th</sup> grade after school, 9<sup>th</sup> at 6:30 pm) under the leadership of Pastor Doug, with assistance from Char Zielin, Molly Stoddard, Hollis Davenport, and occasionally a parent. They cover the Old/New Testament and topics of theology and faith as laid out in the curriculum written by Pastors Doug and Karen. Once a month or so our 7-8<sup>th</sup> grade students get to have a “break” by engaging in a youth group time rather than confirmation class. This is led by Pastor Karen and gives them a chance to exercise their faith in various discussions, and they get to do some traditional “youth group” activities and games. We had our annual fall retreat at Clearwater Forest in early September. It was our largest group yet (we barely had car space for everyone!) and the weekend was great! Our theme was “Jesus Christ-Divine Man of Mystery, and we

covered Old Testament prophecies and manifestations of Jesus as well as His earthly ministry and Second Coming. In addition, we enjoyed being together for games and fellowship. Our leadership included Karen Anderson-Dent, Hollis Davenport, Madalyn Dent, Barb LaPlante, Becca Michael, and Molly Stoddard. As always, it was a wonderful way to kick off the fall!

### **Senior High Youth Group**

Our senior high youth group met each Wednesday night (weather-permitting this past winter/spring!), under the leadership team of Karen Anderson-Dent, Hollis Davenport, Madalyn Dent, and Molly Stoddard. Every week we try to address a topic identified as “interesting” by our youth—who are polled at the beginning of the year. We do our best to encourage one another to find ways to live out our faith in Jesus Christ while discussing current issues and challenges we face in the world. Our group really grew over the last two years, reaching around thirty weeks when everyone was present! This past spring, we celebrated nine graduates. It is so exciting to see where God is taking our young people! We held our annual senior high winter retreat January 20-22 at Clearwater Forest, with Hollis Davenport, Madalyn Dent, and Molly Stoddard leading along with Pastor Karen. Our topic focused on the importance and gift of Sabbath from God to His people. We did our best to rest and have fun as a means of practicing Sabbath! It was a great weekend with beautiful weather.

### **Women’s Bible Study**

Our women’s Bible study meets each Tuesday morning at 11:15 am for a time of prayer and study. This past spring, we studied 1, 2, and 3 John as well as the book of Jude. Due to Pastor Karen’s sabbatical took a break during the second half of the summer, and then started back to study Paul’s epistle to the Philippians. After completing Philippians, we began 1 Samuel, which we will continue well into the 2024 year. Our group adds new members periodically, which is great! We are an open and supportive group who loves to study God’s word together.

### **Vacation Bible School**

We had our annual Vacation Bible School during the week of June 19-23. We had a great turnout—our numbers continue to grow as we add families and friends to our group. Our theme this year was on the Armor of God. Each day we learned about a different part of God’s armor for us, and why He provides this for His believers. We played games, did fun crafts, had good snacks, and just generally had a wonderful time together! The participants raised money for Jail Inc, and Chaplain Pete shared a bit about his ministry with us. We had great adult and youth leadership, including most of our confirmation youth, many of our high school youth, and Lu Echelberger, Melissa Davenport, Caroline Anderson, Jona Brown, Molly Stoddard, Char Zielin and her granddaughters Claire and Ava, and our wonderful snack person Roxane Nereson. If I forgot anyone, I am so sorry! It was a wonderful week, and it could not have happened without such amazing help!

I also want to personally thank the congregation for blessing me with a sabbatical this past summer. It was a wonderful time to rest and reboot after a few challenging years. I am so grateful to serve such a loving and generous and energetic faith family! I’m look forward to seeing where together God takes us next!

### **Highlights of 2023:**

- **Rally Day September 2023:** A large group of our congregation stuck around after church to enjoy home-made pulled pork sandwiches and baked beans. The people at the tables competed in team-trivia, and the younger children enjoyed the bouncy house outside.
- **Ice Fishing Adventure January 2023:** A small group of avid fishermen from our congregation spent a 3-day weekend in a sleeper fish-house at Lake of the Woods. All the weekend's catch ended up as the main ingredient of a fish chowder served to the congregation following one of the Wednesday Lent services.
- **Birthday Cake Sunday February 2023:** Matt Solin has been a big influence to make this one of our bigger events of the year. Extra cakes were auctioned off to supplement our committee's 2023 budget.
- **Softball Breakfast and Silent Auction April 2023:** Along with a fundraiser spaghetti feed during Lent, the softball teams raised over \$2,000 to help finance uniforms and equipment for two teams.
- **Softball Tailgating Event July-August 2023:** With two softball teams, this event was held twice so both teams can take advantage of sharing a picnic lunch with their families and "rub elbows" with the Federated softball fans before their 6:30pm game.
- **Pie Social October 2023:** This has become one of our larger events with over 25 pies being contributed by our talented pie-bakers. The extra pies were auctioned off to supplement our committee's 2023 budget.

### **Goals for 2024:**

- We plan to continue to organize popular events like **Rally Day, Birthday Cake Sunday, Ice Cream Social, Pie Social**, etc.
- In 2023, we began to host church potlucks. We plan to continue hosting potlucks into 2024.
- In general, we expect to continue to take advantage of getting congregation participation by holding most of our events after the Sunday service.

As co-chairperson of the committee, I would like to thank all the committee members for their roles in coordinating events and doing their share to carry out each event to make sure it was a success. I couldn't have asked for a better group to work with this year.

## **Mission Committee**

Thanks to the generosity of congregation members through their financial giving, the Mission Committee was able to give \$8,000 to 13 local, national, and international organizations during 2023.

Highlights of the Mission Committee year were:

- Throughout the year, committee members recruited and coordinated drivers to deliver Meals by Wheels. Thank you to Patty, Jeanette, and Char for their work in contacting volunteers, and a HUGE thank you to all the Federated members who so willingly delivered the meals. At the committee's request, in 2024 Federated Church will be arranging volunteer drivers for one-week periods rather than two-week periods.
- During Food Share Month in March, we continued the Mission Committee tradition of matching congregational donations, contributing \$500 to the Fergus Falls Community Food Shelf.
- Our two Muffins for Mission events (in June and September) raised \$308 for A Place to Belong and \$267 for Boxes of Blessings at the Cancer Care Center; the committee matched these donations with \$308 for A Place to Belong and \$250 for Boxes of Blessings. We also contributed \$200 for garden supplies for A Place to Belong.
- We continued our ongoing support of Habitat for Humanity, recruiting two teams of volunteers to participate in Faith Build days in May and November and covering lunch costs for both days. We also financed the cost of ground insulation for the Habitat build with \$1,237 from the Mission budget (and an additional \$1,237 from the Mission savings account)
- The Mission Brunch was a great success! Caroline Clarin shared the story of Pillars of Friends and Allies. The local non-profit supports Afghan refugee families (who were American allies during the war in Afghanistan) in Pakistani refugee camps as they await legal immigration into the United States. Donations during the brunch totaled \$1,000, and the committee contributed an additional \$500.
- For needs within our congregation, we provided \$2,017 in support to the Local Mission Fund; \$500 for meals for Kids Club; and up to \$1,100 for confirmand donations (\$100 per confirmand).
- The Christmas Joy offering in December (after the deadline for annual report articles), will receive a \$250 match from the Mission Committee.
- Also supported through the Mission Committee during the year were Bible Bingo at the Pioneer Home (\$135); Salvation Army Food Program (\$500); denominational disaster relief (\$200); and Clearwater Forest (\$200).

Our committee's goals in giving were 70 percent local, 20 percent state/national and 10 percent international.

## **Pastoral Care**

I joined the staff of Federated as the Director of Pastoral Care a little over a year ago. I've enjoyed getting to know many members of Federated and to hear the stories of your life and your faith. Thank you for inviting me into the sacred moments of your life where together we have dwelled in Christ's presence. And of course, the ministry of caring for one another is not something that I do alone. It is a ministry that involves the entire congregation of Federated Church as we walk together as a faith family holding each other in prayer and supporting one another in so many ways.

- Thank you to Millie Pearson, Nancy Gardner, and Norma Worden, for continuing to share your gift of knitting/crocheting prayer shawls and baptismal blankets. Your time and talents do not go unnoticed. The prayer shawls are given to members having surgery, going through treatments, or experiencing other events in their lives as a sign of God's comfort to them and the prayers of the congregation with them. We also deliver prayer shawls to the Cancer Center to be given to patients there.
- With the help of volunteer drivers (Renee and Russ Larsen, John MacFarlane, Dave Nord, Lu Echelberger, Char Zielen, Bill and Peg Kalar, and Paul Shol) we delivered 148 porch bags/meals this year. This is a ministry that continues to share a meal with those that are at home, sick, healing, mourning, experiencing joy or just maybe need an extra "hug" from the congregation. This simple meal consists of soup, bread, a sweet treat, devotion, and a handwritten note.
- 55 Boxes of Blessing were delivered to the Fergus Falls Cancer Center. This continues to be an outreach and mission project for our congregation. A team of nurses and staff at the center put together a list of helpful items to gift those that are starting to receive treatments. We also delivered boxes of blessings to 2 people receiving treatment at other facilities. Thank you to the youth group who helped put together many of these boxes. Thank you for the generous monetary donations to keep this project going.
- This year we (re)started a ministry of giving a bag of items to people who have transitioned to assisted living or long-term care facilities to help them feel more at home and cared for in their new place. These bags consist of some Federated items (bookmark, pen, magnet), self-care items (lotion, ChapStick, Kleenex), a cross and a handwritten note.
- In a joint ministry with Hope Lutheran, we offered a Bible Study during the Lenten season that focused on grief and the connections of our experience of grief with Scripture.
- The Federated Friends group continues to keep in contact with their friends through phone calls, letters, and in person visits.
- The Federated mission fund used \$507.02 as outreach for meals and those in need within our faith family.
- The local mission fund used \$3,614.06 to help individuals in our community with food vouchers and utility bills. This is a wonderful mission that Federated can offer to our community and those that are struggling.

Thank you for allowing me to be a part of your journey. The connections and visits in your homes, hospital rooms, over coffee and prayer, letters, text messages and phone calls have been a blessing.

Our stewardship theme this year was Measuring What Matters. It was rich with reminders of how we are blessed by God and how God invites us to respond. What we believe matters. What we do about what we believe matters even more.

We had a successful campaign, reaching 95% of our goal of \$408,614 with \$388,513.48 pledged.

Thank you to everyone who returned your 2024 estimate of giving card, helping us to appropriately budget for what we need, what we want, and what we wish for. Your support helps put our faith into action both in our church and in our community.

Every pledge matters. Of the households that pledged for 2024, 38 households increased their pledge, and 50 households continued their support at 2023 levels. Nine households pledged for the first time. What a blessing!

The Deacons & Elders reviewed the results of the stewardship campaign and noted that:

- 30 households provide 74.46% of the annual budget.
- 79 households provide the remaining 25.54% of the annual budget.
- More than 100 households made no pledge for 2024.

We are truly grateful for the generosity of our members. Next year we hope to engage even more members with our mission through time and financial support for our important ministries.
